



**Sir,**

The inspection of above said school was got carried out by the inspecting officer of this department. During inspection it was found that the management has installed only 05 Nos. First Aid Fire Extinguishers in their school premises, besides one water storage tank of 50 KL capacity. The school is about 06 Km away from Fire & Emergency Station Rajouri and is approachable for fire appliances in case of any emergency. Since the school is already functioning as such, the management can proceed ahead for operation provisionally subject to strictly adopt the following fire safety measures in letter and spirit forthwith:--

1. All exits/entrances should be kept open and free from any obstruction for easy and safe evacuation of inmates during any emergency.
2. 04 Nos. ABC Stored Pressure Type Fire Extinguisher of 04 Kg capacity each should be provided in Academic Block and 02 Nos. Clean Agent Type Fire Extinguishers of 02 Kg capacity each should be provided in computer lab, besides 01 No. ABC Stored Pressure Type Fire Extinguisher of 04 Kg capacity in each block i.e. Art & Craft Block, Library Block and in Assembly shed respectively in addition to already existing fire extinguishers.
3. First Aid firefighting system installed in the school building should be checked periodically. Staff and students should be fully trained in handling/operating of firefighting system installed in the School building. The management shall intimate the office of Assistant Director, Fire & Emergency Services Command Rajouri - Poonch after each quarter that the firefighting equipment installed in the school are functioning.
4. All class rooms and examination halls having seating capacity for more than 45 students need to be provided with two exits.
5. The corridor of the building shall not be used for any kind of storage.
6. No Hazardous material should be kept inside of the school premises (especially LPG cylinder, Petrol and Diesel etc.). Any deviation found in this regard, this provisional clearance will be treated withdrawn/cancelled.
7. One window of each class room should be without iron grill so that it can be used for safe evacuation of inmates during any mishap.
8. The management of the school shall be wholly and solely responsible for keeping the firefighting system in working condition 24x7 and safe evacuation of its students during any mishap.
9. At present school is having five blocks, one is double storied and other four are single storied. As such no addition/alteration should be made by the school management in the existing structure without prior permission from this department. Any deviation found in this regard, this provisional clearance will be treated withdrawn / cancelled.
10. Telephone numbers of nearest Fire & Emergency Stations should be displayed.
11. The validity of this provisional clearance shall remain in force for six months and the school management approached this office accordingly after implementation of above said fire safety measures within stipulated period of time for issuance of final fire safety certificate.
